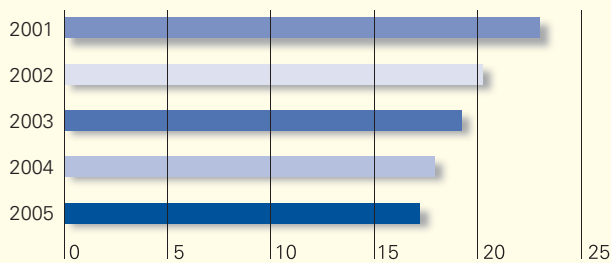

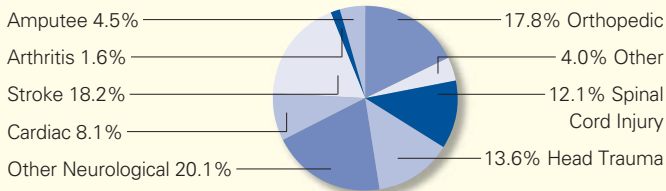

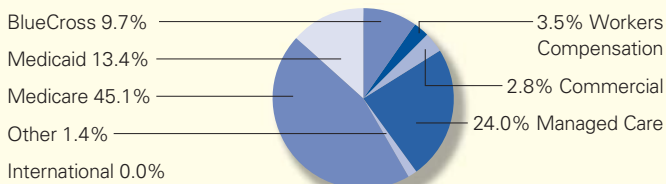
### Average Length of Stay – Days



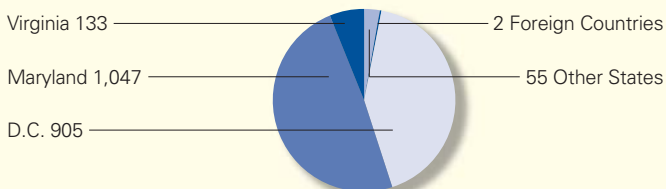
### Disability Class (FY 2005)

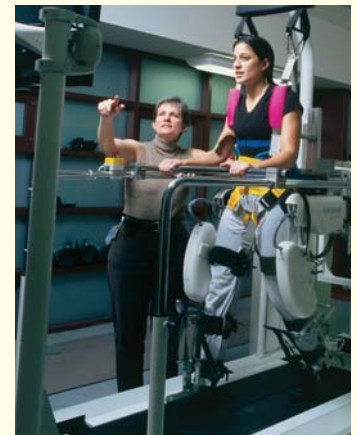
